#### s. 66.1001(2)(i) Wis Stats

The *Implementation Element* is a compilation of programs and specific actions to be completed in a stated sequence, including any proposed changes to any applicable zoning ordinances, official maps, sign regulations, erosion and storm water control ordinances, historic preservation ordinances, site plan regulations, design review ordinances, building codes, mechanical codes, housing codes, sanitary codes or subdivision ordinances, to implement objectives, policies, plans and programs contained in pars. (a) to (h). The element shall describe how each of the elements of the comprehensive plan will be integrated and made consistent with the other elements of the comprehensive plan, and shall include a mechanism to measure the local government's progress toward achieving all aspects of the comprehensive plan. The element shall include a process for updating the comprehensive plan. A comprehensive plan under this subsection shall be updated no less than every 10 years

There are multiple elements involved in the comprehensive planning process. Of all the steps, implementation requires the most attention and has typically been the most problematic for the vast majority of communities. Once the comprehensive plan is adopted, a significant new phase begins — implementation. A comprehensive plan is of little use to a community if it is not being implemented.

"Implementation involves any action or activity following plan adoption that helps to achieve the vision outlined in this plan"

Implementation is a critical component of Wisconsin's smart growth legislation. All actions of a local government that affect land use must be consistent with its comprehensive plan by January 1, 2010. Completing and adopting a comprehensive plan is an important accomplishment for a community, but once the plan is adopted the efforts must continue. A great deal of effort is needed following plan adoption to bring the Town's rules and regulations into compliance.

#### **Implementation Schedule**

The implementation schedule provided in this section is a listing of all of the activities and actions necessary to implement the intentions of this comprehensive plan. The activities correspond to multiple aspects of the plan, and are grouped accordingly. Some of these groupings relate directly to various elements of the plan, while others do not.

The range and difficulty of implementation actions contained in this section varies based on length of time it will take to complete. Some of the items will be relatively simple and require little effort, while others are more complicated and will take more time and resources to complete. Based on these variations, it should be apparent that it will take a number of years to fully implement this plan. The items listed in the schedule include an approximate implementation date, as well as a responsible party. This outline provides a framework for the Town to follow when implementing its comprehensive plan.

The upkeep of this list will be necessary in order to ensure that the implementation items listed are being achieved. Some of the items are ongoing, and will not see a completion date. Others should be removed from the list when they have been completed in order to keep this schedule up to date. It is recommended that the Town Board conduct an annual review of this section to ensure that the steps and actions necessary to implement the plan are being done in a timely manner.

It is necessary to work continuously to ensure that the plan is being utilized, implemented, and updated. A standing committee called the Comprehensive Plan Committee (CPC) will be created, consisting of from three to five members who were involved in the formation of the plan. This CPC will meet at least twice annually and will be charged with "keeping the plan." The CPC will meet before the Town Board prepares its budget, so the committee can advise the board as to what funds it may need for the upcoming year to accomplish its tasks and again in March, to prepare a report for the Town meeting. It may meet at other times as needed.

The committee members should initially be from the comprehensive plan advisory committee but gradually be replaced by others from the Town, so that knowledge of our plan will be updated, ongoing, and dispersed throughout the community. Tasks of the committee will be to undertake those tasks and actions listed as being the responsibility of the CPC and to assist the Plan Commission in conducting a comprehensive review of the comprehensive plan every five years. The committee will report to the Town plan commission.

The implementation schedule provides a wide range and scope for the types and number of items to be completed. Although some of these items are quite simple to accomplish and will require minimum resources, others are extensive. The more complicated items will entail more time, and consequently, could benefit from the aid of outside resources.
