LAND USE AD HOC COMMITTEE REPORT

The Town of River Falls Land Use Ad Hoc Committee continues to work on the town's Farmland Preservation Plan. In conjunction with this, the committee has been working with landowners and other neighboring towns that are interested in finding out more information on Agriculture Enterprise Areas which are designations approved by the Wisconsin Department of Agriculture. As their work progresses please watch the town website, River Falls Journal and your mailbox for more information. Public hearings will be held to detail

the committee's work and to allow for the public to weigh in on the future look of our town. The Land Use Ad Hoc Committee meets the first Thursday of each month at 6:30 P.M. at the Town Hall. Meetings are open to the public.

LARGE GATHERING PERMITS

Town board members frequently get asked what constitutes a large gathering requiring a town permit. The large gathering permit is required for any gathering where a fee is charged or where there are expected to be over 300 people gathered in one location at the same time for more than six hours. The ordinance regulates sanitary facilities, drinking water, solid waste, fencing, traffic control, parking, emergency procedures, liquor and food licensing, and notification to the neighbors. Residents meeting the ordinance criteria need to complete an application form and submit an application fee at least 30 days prior to the event. The form is located on the town website. In addition. the applicant will be requested to attend a Town Board Meeting to discuss their plans.

GLASS VALLEY CEMETERY

A cemetery walk is planned for Sunday, September 7, 2014 from 1:00 PM- 3:00 PM. It will feature a reenactment of the Glass family history. Cyrus and Sally Glass, along with three sons, two daughters and several other family members landed in Prescott on May 22, 1856. At one time, there were 35 Glass family members living in the area.

Elizabeth Terlinden has spent many hours researching the Glass family. We hope to have actors from the 4-H Club portray Glass Family members.



Our goal at the Glass Valley Cemetery is to utilize the burial space that is available and to use the funds obtained to do needed repair. Three lots have been sold with one burial in one of those lots. Many more lots are available. We are replacing the fence wire along County E and creating a parking place off the road. The fence wire was chosen to match the 100 year old wire that is there now. We also want to repair some of the broken markers and put up a flagpole.

The Town and Country 4-H Club has provided mowing services as part of their community service commitment for over 50 years.

The Cemetery Committee consists of Diana Smith, Leroy Kusilek, Al Pechacek, Scott and Peggy Jensen, Elizabeth Terlinden and Jerome Rodewald. The Glass Valley Cemetery is located at the corner of Hwy. 29S and County Road E.

NEW LOWER PRICES ON APPLIANCE RECYCLING

Standard household appliances are now \$10.00. This includes freezers, washers, dryers, stoves, refrigerators, dehumidifiers, water heaters, dishwashers and furnaces. Microwaves are \$5.00 - \$10.00. Air conditioners and water softeners are \$15.00.

TOWN BURN PERMITS

It is important for town residents to pick up a burn permit before they undertake any burning activities involving more than a small campfire. The permits are available at the Town Recycling Center during center hours, or from a town board or staff member by appointment. Acquiring a burn permit may help you avoid a costly false alarm fire call. Permits are good for the entire calendar vear. Permit holders must notify the local sheriff"s department prior to starting any burning activities.
