U.S. MAIL – Pierce County Treasurer, PO Box 87, Ellsworth, WI 54011 – <u>Must be postmarked on or</u> <u>before January 31, 2016</u>. For year end payments (Dec 31) your receipt will show the date payment was received not the postmark date. Please make payment to <u>Pierce County Treasurer</u>. Enclose tear off from tax statement so payment will be applied correctly. However, if there are delinquent taxes, payment will be applied to delinquent taxes first. *If you want a receipt(s) please include a self-addressed envelope with appropriate postage*. <u>Please do not include fees for dog licenses with your property tax payment</u>. Dog licenses will be issued by the town treasurer (instructions below).

CREDIT CARD – Credit Cards AND electronic check payments

If you wish to pay taxes by credit card or electronic check, a processing fee will be added to your payment. Please go to the Pierce County website <u>www.co.pierce.wi.us</u> On the home page, go to the left to the Departments tab, go to treasurer office. On the far right, click on top link - Online Tax Payment Information. The credit and debit card fee is 2.39% of the amount being paid (minimum fee \$1.50). Electronic check fee is \$1.50 (for payments up to \$10,000). You need your parcel computer number and dollar amount to complete the transaction.
