*No permit needed for replacement of already permitted items (windows, siding, shingles) or repainting. Damage by fire or wind – Any damage that exceeds \$2500 (unless already exempted) would require a remodel permit

BUILDING INSPECTION FEES:

- New one and two family dwelling & commercial construction: \$800.00 flat fee plus \$.10 per square foot.
- Modular or manufactured assembled home to be placed upon a permanent basement foundation shall be \$600.00 flat fee plus \$.10 per square foot. - Above fees include the construction of attached structures that are part of the submitted plan, such as an attached garage, deck, or porch.
- Manufactured assembled home to be placed upon a slab, piers, or non - permanent foundation shall be \$450.00 flat fee.
- Any building cost (additions, alterations, or remodeling) over \$100,000.00 will be considered new construction. Building cost will be measured according to the RS Means Standard if applicable.

- Any building cost (additions or *remodeling*) under \$100,000 will be charged per inspection type, types listed under Services. Fee's for one and two family dwellings will be \$60.00 per inspection type and fees for commercial buildings will be \$100.00 per inspection type, number to be determined by building inspector at plan review. Building Cost will be measured according to the RS Means Standard if applicable.
- Permit Renewal Fee: Half original fee minimum \$50.00 maximum \$250.00
- Re-inspection fee \$60.00 for One & Two family dwelling, \$100.00 for Commercial
